Chairman's Report

This report covers the year 1st April 2020 - 31st March 2021.

Clearly this year has been dominated by Covid-19 and the impact it has had on all of us, as individuals, families and communities alike.

Our primary project, Braehead Community Garden, was impacted hugely and the trustees took the decision to suspend new raised bed hires and to allow those with access in the 2019 growing season to continue to be able to come into the garden, although everyone was required to bring in their own tools etc. if they wished to grow vegetables. A decision was also taken to effectively close the polytunnels in line with guidance around enclosed and indoor spaces. A proposal from the growing team was made to grow the crops that had been propagated in the polytunnels prior to lockdown and a protocol and rota was devised to ensure that this could be done safely. This was approved by the trustees and the growing group produced a bumper harvest in the polytunnels and also from the external market garden. Later in the summer, a range of vegetables were donated to Heart of Braehead's community food bank, providing fresh, healthy, local produce for people in need living locally. Other produce was distributed to fellow gardeners with some choosing to leave donations for the fantastic tomatoes. This was thanks to the ongoing determination, hard work and generosity of the growing group.

An innovative UV filtration system was installed to provide safe hand washing facilities using harvested rainwater ensuring that enhanced hygiene measures could be provided to those accessing the garden.

The hen group continued to work hard to ensure that the hens' welfare was maintained while humans adhered to social distancing measures. The hens also provided a highlight for the local dog walking circuit and many conversations were struck up through the fence with people taking their daily exercise.



During the first lockdown, the trust worked as a community anchor organisation and offered support to vulnerable members of our community by delivering shopping and checking in with them. This was done in partnership with Stirling Council and was part of a wider response to these truly unforeseeable circumstances. It is fair to say that networks of support sprang up across the area and it was fantastic that the trust were able to be a part of this.

While the garden was not able to operate at full capacity, we were still able to deliver two significant infrastructure projects that are hard to miss! Firstly, the solar array's installation was delayed due to covid and was finally constructed in autumn 2020. The panels will deliver clean, sustainable electricity that will more than meet the needs of people using the garden with excess production being fed into the grid creating income for the trust and community garden. While I am slightly baffled by the significance of the numbers relating to the energy being produced, I have been assured that the system is highly effective, even in the shorter days of autumn and winter.

The second infrastructure project of this year was the building of polytunnel 4. It seems that many funding opportunities currently involve extremely tight turnarounds in terms of application processes, with this being no exception. Many hours of unseen hard work went into ensuring that the application and build were delivered on time, again I offer my thanks to those involved. Sadly the ongoing covid situation meant that we have been unable to use this as a growing space, however I think the addition of these 2 new structures has provided a striking contrast between nature's organic work and the man made geometric shapes of the polytunnel and solar array.

What was very evident throughout the varying levels of restrictions during the year, was that the garden provided a place where people's mental health and wellbeing could be nurtured when other aspects of daily life were anything but stress-free. Many used the garden as somewhere peaceful to do their daily exercise or just maintain their



own vegetables while having some socially distanced conversation. This displays the value of the garden as a community resource and our hope is that the Trust and the garden project will play a key role in Braehead and Broomridge's response and recovery from the pandemic.

Annual Accounts

Notes on the accounts

In year 2020/21, the CDT had:

Income of £55,536.56. These funds were raised through two broad areas of operation:

Fundraising through grant applications for enhancement projects within Braehead Community Garden (£52,520.87). This funding in this year is from Clackmannanshire and Stirling Environment Trust, Climate Challenge Fund (Keep Scotland Beautiful) and Scottish Power Green Energy with match funding of elements of our infrastructure projects.

Operational income associated with Braehead Community Garden, including the sale of memberships for year 2021/22, hire of the facilities to third parties, plant sales and kitchen garden vegetable and fruit sales and a Covid 19 grant from the Corra Foundation (£3,015.69).

Expenditure of £75,464.61. These expenditure were revenue and capital.

Revenue funds associated with the operation of Braehead Garden (£6,491.23). These figures are reduced for this year as the garden day to day operations was impacted by Covid 19 restrictions.

Capital funds associated with infrastructure costs with Braehead Community Garden (£68,973.30). This was work to complete the installation of our 30kw solar panel array and the purchase and built of a fourth polytunnel.
